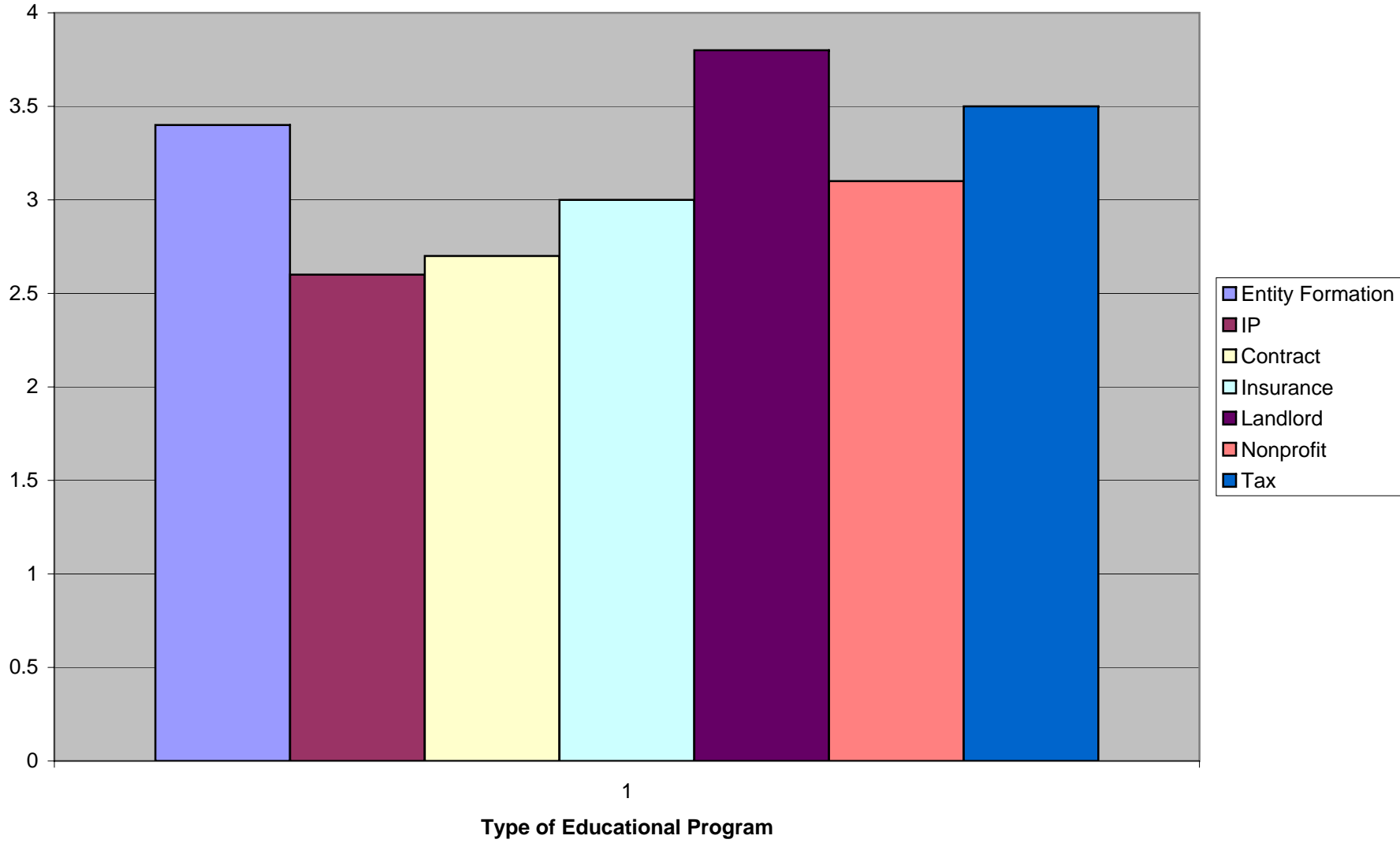
### Previous Legal Issues I was Involved In



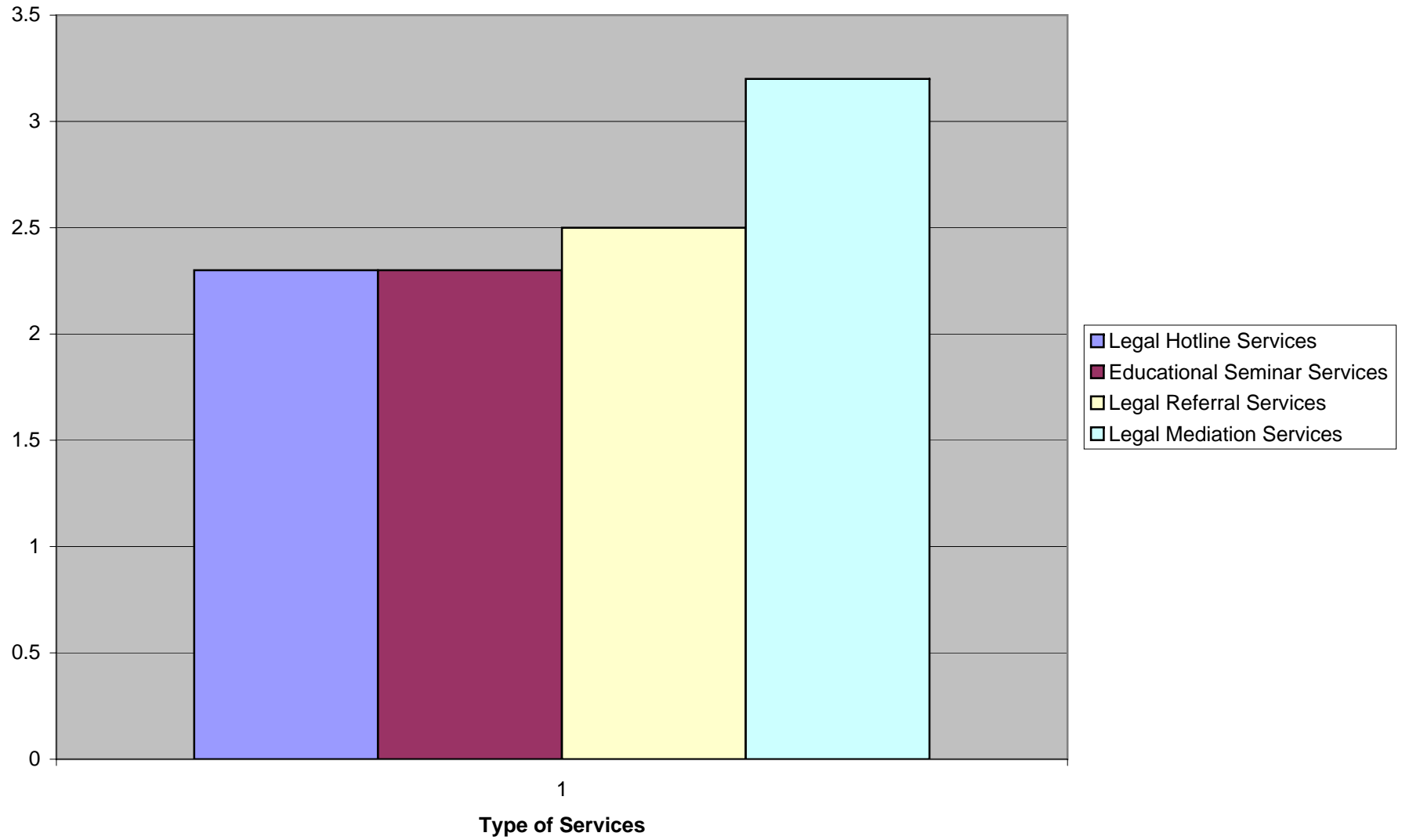
### How Much I am Willing to Pay



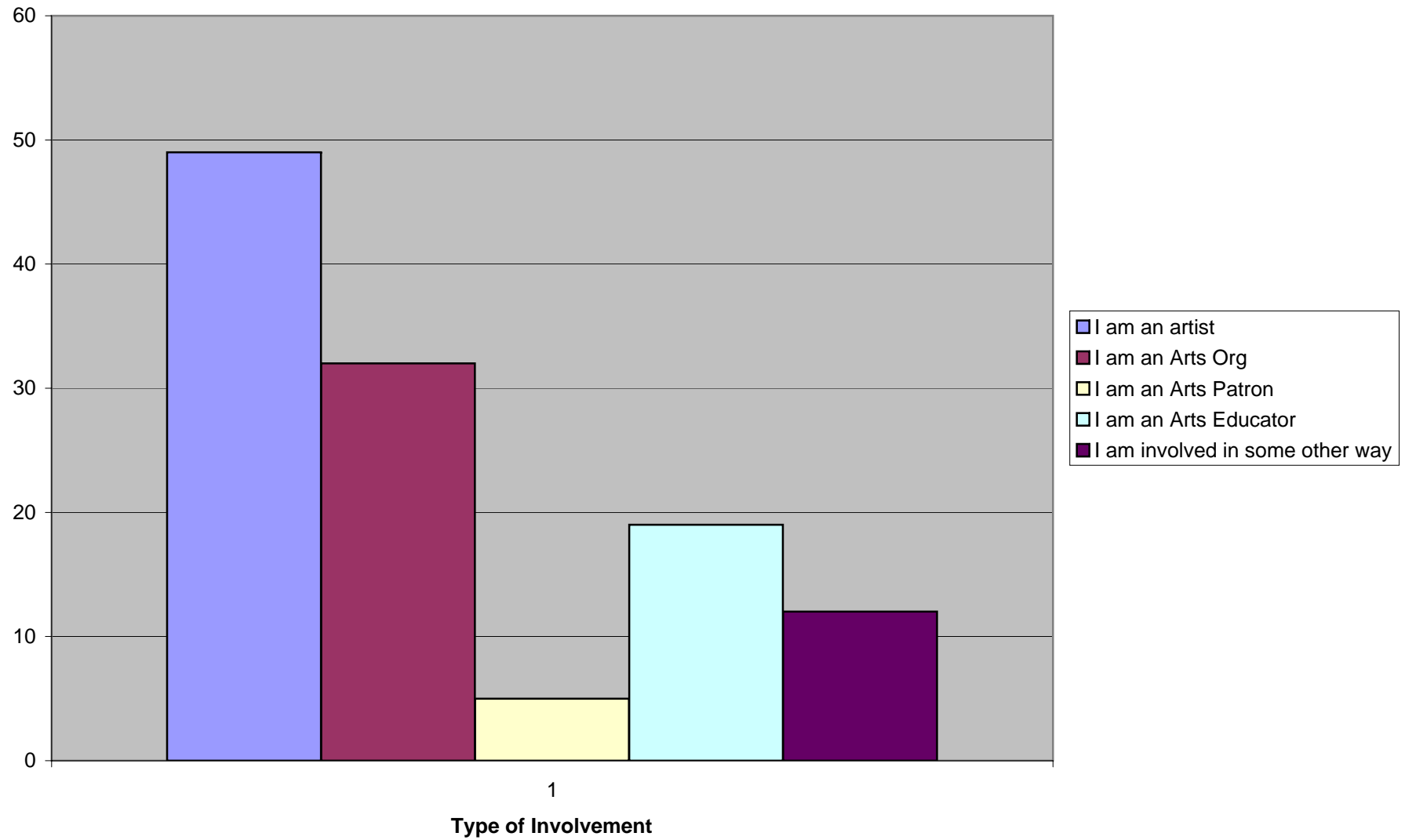
### How I Rank Educational Programs



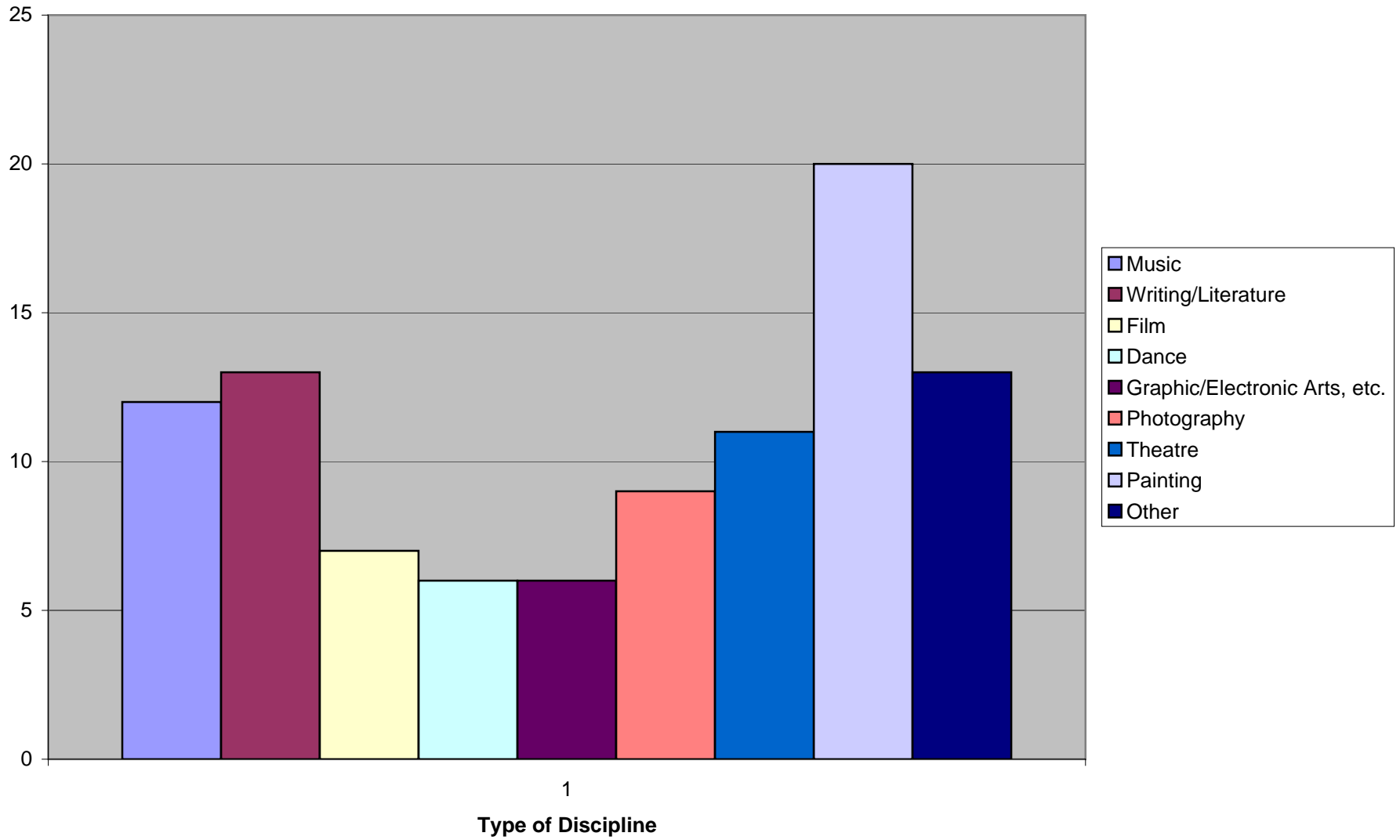
### How I Rank Services (Scale of 1 to 5)

## NEEDS SURVEY 2005

New Jersey Volunteer Lawyers for the Arts, Inc. ("NJVLA") is an initiative to provide legal education, representation, and other legal services to the entire State's arts community, and in particular to low income artists and non-profit arts organizations.

NJVLA intends to provide services in three primary areas – legal education, legal referrals and representation, and dispute resolution. The arts community will obtain legal support and education, including education for artists about their rights and responsibilities in developing, protecting, and realizing the value in their work. Legal referrals will involve matching lawyers with skills and experience that match the need of a specific, qualifying, artist or organization, and to perform the work *pro bono*. As examples, a lawyer may assist an artist in licensing work, reviewing a lease for studio space, or properly registering copyrights, or may assist an arts organization in forming and maintaining a legal entity. Through legal education, NJVLA will seek to provide artists and organizations with basic legal education, to enable them to identify issues that may require professional assistance. As artists are better able to protect, distribute, and benefit from their own work, they will be in a much better position to enrich the lives of New Jersey citizens and to participate in the economy.
